SPECIFICATIONS

1. SCOPE. This specification covers mineral oil for use in hydraulic turbine and generator bearings, Kaplan turbine hubs, hydraulic turbine governors, and other applications where high-grade lubricating oil having anti-corrosion, anti-oxidation, and anti-foaming properties is required. In conformance with these specifications, the Contractor shall furnish and deliver 5000 gallons of R&O ISO 100 turbine oil to Lower Granite Dam, Pomeroy WA. Testing, analysis, and delivery shall be performed at no additional cost to the Government.
2. APPLICABLE PUBLICATIONS. The following publications form a part of this specification to the extent indicated below. While complete citations are given in paragraphs 2.1 and 2.2, the documents are referred hereafter by basic designation only.

3. TYPE OF OIL. The turbine lubricating oil furnished under these specifications shall be a blend of virgin petroleum-based lubricating oil stocks plus additive agents to meet the requirements of these specifications. Additive components contained in the finished lubricating oil shall be the same as those in the approved sample.

4. CHEMICAL AND PHYSICAL CHARACTERISTICS. At no additional cost to the Government, the Contractor shall test the proposed oil and shall certify the oil meets the test values listed in Table 1. In addition, at no additional cost to the Government, the Contractor shall perform tests and certify the oil to be delivered meets the requirements of paragraph 6, DEGRADATION, paragraph 7, HOMOGENEITY, and paragraph 8, COMPATIBILITY. Oil failing to meet the requirements shall be replaced at the expense of the Contractor. Following all testing and Government approval, the oil furnished will be mixed with in-service oil at the dam.

5. SAMPLING AND TESTING.

5.1 Sampling. Samples for testing shall be obtained as specified in ASTM D4057 or ASTM D4177.5.2 Testing. Chemical and physical tests shall be conducted in accordance with the Standards listed in Table 1.

6. DEGRADATION. The quality of the oil shall not be appreciably degraded (changed) by filtration through mechanical filters, by centrifugal purification, or by vacuum type purification, all of which have been designed for lubricating oil.

7. HOMOGENEITY. Additive agents shall remain uniformly distributed throughout the oil at all temperatures above the pour point and up to 250⁰F (120⁰C). When the oil is cooled below the pour point, it shall regain homogeneity on standing at temperatures of 10⁰F (5⁰C) above the pour point.

8. COMPATIBILITY. The Government will provide to the successful bidder one gallon of the in-service oil from the dam for compatibility testing, free of any charges. The Contractor shall perform compatibility testing of the in-service oil and the new oil at various mixing ratios (i.e. 100/0, 85/15, 50/50, 15/85, and 0/100), and certify that the new oil is compatible with the in-service oil. Two oils are considered compatible if, at the end of the test, the mixture is free of phase separation and formation of precipitation or cloudiness, retains homogeneity, and meets all requirements listed in Table 1. Alongside the certificate, The Contractor shall provide the Government with a written description of the procedure that was used for the compatibility testing and evaluation. The Contractor shall accomplish all tests at no cost to the Government. A minimum of 30 days before the oil delivery and purchase, the Contractor shall provide the Government with one gallon of the new oil, free of any charges, which will be used for an independent testing by the Government. The Government will cover all costs for their independent testing.

9. REPORTING.

9.1 Independent Testing. At no additional cost to the Government, the Contractor shall, if needed, arrange for an independent testing company to perform all Contractor oil sampling, testing and certifications that are required under these specifications.

9.2 Test Reports. Along with a letter indicating the contract number and the name of the Contractor, the Contractor or the Contractor's independent test company shall furnish, directly to the Contracting Officer, four copies of the test data and certifications required in paragraph 4. The certifications and test data shall be submitted for Government approval at least 30 days before the proposed date of oil delivery. The Contracting Officer will forward three copies of the test reports to Rob Lustig (509) 843-1493 x258 at Lower Granite Dam for approval. The Contracting Officer will notify the Contractor regarding approval of test reports.

10. DELIVERY.

10.1 Scheduling. All oil shall be delivered to Lower Granite on or before 1 September 2004. The Contractor shall schedule the delivery and storage of oil to the dam with the Project Point of Contact (POC) or their designee. The Lower Granite POC is Rob Lustig (509) 843-1493 x258. Delivery shall be scheduled between Monday and Thursday, 0730 hours to 1500 hours, unless approved otherwise.

10.2 Delivery. The delivery truck shall travel to the Power House assembly bay from the Pomeroy (South) side of the river. The truck shall not cross the dam. Upon arrival and before pumping the new oil into the Government storage tank, the driver shall pour three gallons of new oil from the truck into government supplied storage containers for future testing. The Contractor shall then pump the oil into the Government storage tank.

CLAUSES INCORPORATED BY FULL TEXT

52.204-7 CENTRAL CONTRACTOR REGISTRATION (OCT 2003)

(a) Definitions. As used in this clause--

Central Contractor Registration (CCR) database means the primary Government repository for Contractor information required for the conduct of business with the Government.

Data Universal Numbering System (DUNS) number means the 9-digit number assigned by Dun and Bradstreet, Inc. (D&B) to identify unique business entities.

Data Universal Numbering System +4 (DUNS+4) number means the DUNS number assigned by D&B plus a 4-character suffix that may be assigned by a business concern. (D&B has no affiliation with this 4-character suffix.) This 4-character suffix may be assigned at the discretion of the business concern to establish additional CCR records for identifying alternative Electronic Funds Transfer (EFT) accounts (see the FAR at Subpart 32.11) for the same parent concern.

Registered in the CCR database means that--

(e) Processing time, which normally takes 48 hours, should be taken into consideration when registering. Offerors who are not registered should consider applying for registration immediately upon receipt of this solicitation.

(f) The Contractor is responsible for the accuracy and completeness of the data within the CCR database, and for any liability resulting from the Government's reliance on inaccurate or incomplete data. To remain registered in the CCR database after the initial registration, the Contractor is required to review and update on an annual basis from the date of initial registration or subsequent updates its information in the CCR database to ensure it is current, accurate and complete. Updating information in the CCR does not alter the terms and conditions of this contract and is not a substitute for a properly executed contractual document.

(g)(1)(i) If a Contractor has legally changed its business name, "doing business as" name, or division name (whichever is shown on the contract), or has transferred the assets used in performing the contract, but has not completed the necessary requirements regarding novation and change-of-name agreements in Subpart 42.12, the Contractor shall provide the responsible Contracting Officer a minimum of one business day's written notification of its intention to (A) change the name in the CCR database; (B) comply with the requirements of Subpart 42.12 of the FAR; and (C) agree in writing to the timeline and procedures specified by the responsible Contracting Officer. The Contractor must provide with the notification sufficient documentation to support the legally changed name.

(ii) If the Contractor fails to comply with the requirements of paragraph (g)(1)(i) of this clause, or fails to perform the agreement at paragraph (g)(1)(i)(C) of this clause, and, in the absence of a properly executed novation or change-of-name agreement, the CCR information that shows the Contractor to be other than the Contractor indicated in the contract will be considered to be incorrect information within the meaning of the "Suspension of Payment" paragraph of the electronic funds transfer (EFT) clause of this contract.

(2) The Contractor shall not change the name or address for EFT payments or manual payments, as appropriate, in the CCR record to reflect an assignee for the purpose of assignment of claims (see FAR Subpart 32.8, Assignment of Claims). Assignees shall be separately registered in the CCR database. Information provided to the Contractor's CCR record that indicates payments, including those made by EFT, to an ultimate recipient other than that Contractor will be considered to be incorrect information within the meaning of the "Suspension of payment" paragraph of the EFT clause of this contract.

(a) Definitions. As used in this clause--

“Central Contractor Registration (CCR) database” means the primary Government repository for contractor information required for the conduct of business with the Government.

“Commercial and Government Entity (CAGE) code” means--

(1) A code assigned by the Defense Logistics Information Service (DLIS) to identify a commercial or Government entity; or

(2) A code assigned by a member of the North Atlantic Treaty Organization that DLIS records and maintains in the CAGE master file. This type of code is known as an “NCAGE code.”

“Data Universal Numbering System (DUNS) number” means the 9-digit number assigned by Dun and Bradstreet, Inc. (D&B) to identify unique business entities.

“Data Universal Numbering System +4 (DUNS+4) number” means the DUNS number assigned by D&B plus a 4-character suffix that may be assigned by a business concern. (D&B has no affiliation with this 4-character suffix.) This 4-character suffix may be assigned at the discretion of the business concern to establish additional CCR records for identifying alternative Electronic Funds Transfer (EFT) accounts (see Subpart 32.11 of the Federal Acquisition Regulation) for the same parent concern.

“Registered in the CCR database” means that--

(1) The Contractor has entered all mandatory information, including the DUNS number or the DUNS+4 number, into the CCR database;

(2) The Contractor's CAGE code is in the CCR database; and

(3) The Government has validated all mandatory data fields and has marked the records “Active.”

(b)(1) By submission of an offer, the offeror acknowledges the requirement that a prospective awardee shall be registered in the CCR database prior to award, during performance, and through final payment of any contract, basic agreement, basic ordering agreement, or blanket purchasing agreement resulting from this solicitation.

(2) The offeror shall enter, in the block with its name and address on the cover page of its offer, the annotation "DUNS" or "DUNS +4" followed by the DUNS or DUNS +4 number that identifies the offeror's name and address exactly as stated in the offer. The DUNS number will be used by the Contracting Officer to verify that the offeror is registered in the CCR database.

(c) If the offeror does not have a DUNS number, it should contact Dun and Bradstreet directly to obtain one.

(1) An offeror may obtain a DUNS number--

(i) If located within the United States, by calling Dun and Bradstreet at 1-866-705-5711 or via the Internet at <http://www.dnb.com>; or

(ii) If located outside the United States, by contacting the local Dun and Bradstreet office.

(2) The offeror should be prepared to provide the following information:

(i) Company legal business.

(ii) Tradestyle, doing business, or other name by which your entity is commonly recognized.

(iii) Company Physical Street Address, City, State, and Zip Code.

(iv) Company Mailing Address, City, State and Zip Code (if separate from physical).

(v) Company Telephone Number.

(vi) Date the company was started.

(vii) Number of employees at your location.

(viii) Chief executive officer/key manager.

(ix) Line of business (industry).

(x) Company Headquarters name and address (reporting relationship within your entity).

(d) If the Offeror does not become registered in the CCR database in the time prescribed by the Contracting Officer, the Contracting Officer will proceed to award to the next otherwise successful registered Offeror.

(e) Processing time, which normally takes 48 hours, should be taken into consideration when registering. Offerors who are not registered should consider applying for registration immediately upon receipt of this solicitation.

(f) The Contractor is responsible for the accuracy and completeness of the data within the CCR database, and for any liability resulting from the Government's reliance on inaccurate or incomplete data. To remain registered in the CCR database after the initial registration, the Contractor is required to review and update on an annual basis from the date of initial registration or subsequent updates its information in the CCR database to ensure it is current, accurate and complete. Updating information in the CCR does not alter the terms and conditions of this contract and is not a substitute for a properly executed contractual document.

(g)(1)(i) If a Contractor has legally changed its business name, “doing business as” name, or division name (whichever is shown on the contract), or has transferred the assets used in performing the contract, but has not completed the necessary requirements regarding novation and change-of-name agreements in Subpart 42.12, the Contractor shall provide the responsible Contracting Officer a minimum of one business day's written notification of its intention to (A) change the name in the CCR database; (B) comply with the requirements of Subpart 42.12 of the FAR; and (C) agree in writing to the timeline and procedures specified by the responsible Contracting Officer. The Contractor must provide with the notification sufficient documentation to support the legally changed name.

(ii) If the Contractor fails to comply with the requirements of paragraph (g)(1)(i) of this clause, or fails to perform the agreement at paragraph (g)(1)(i)(C) of this clause, and, in the absence of a properly executed novation or change-of-name agreement, the CCR information that shows the Contractor to be other than the Contractor indicated in the contract will be considered to be incorrect information within the meaning of the “Suspension of Payment” paragraph of the electronic funds transfer (EFT) clause of this contract.

(2) The Contractor shall not change the name or address for EFT payments or manual payments, as appropriate, in the CCR record to reflect an assignee for the purpose of assignment of claims (see FAR Subpart 32.8, Assignment of Claims). Assignees shall be separately registered in the CCR database. Information provided to the Contractor's CCR record that indicates payments, including those made by EFT, to an ultimate recipient other than that Contractor will be considered to be incorrect information within the meaning of the “Suspension of payment” paragraph of the EFT clause of this contract.

Security Contract Language for all Corps of Engineers' Unclassified Contracts (PIL 2003-06, 19 Feb 03)

All Contractor employees (U.S. citizens and Non- U.S. citizens) working under this contract (*to include grants, cooperative agreements and task orders*) who require access to Automated Information Systems (AIS), (stand alone computers, network computers/systems, e-mail) shall, at a minimum, be designated into an ADP-III position (non-sensitive) in accordance with DoD 5220-22-R, Industrial Security Regulation. The investigative requirements for an ADP-III position are a favorable National Agency Check (NAC), SF-85P, Public Trust Position. The contractor shall have each applicable employee complete a SF-85P and submit to the Security Officer within three (3) working days after award of any contract or task order, and shall be submitted prior to the individual being permitted access to an AIS. Contractors that have a commercial or government entity (CAGE) Code and Facility Security Clearance through the Defense Security Service shall process the NACs and forward visit requests/results of NAC to the Security Officer. For those contractors that do not have a CAGE Code or Facility Security Clearance, the Security Office will process the investigation in coordination with the Contractor and contract employees.
