SPECIFICATIONS

TECHNICAL SPECIFICATIONS JFF VALVE & ACTUATOR PURCHASE

1.0 INTENT

The following specifications pertain to the purchase of eleven valves with actuators at Little Goose Lock and Dam Juvenile Fish Facility. This purchase is to include one 8”dia and ten 12”dia butterfly valves each equipped with a pneumatic actuator w/ manual override.

2.0 SCOPE

The successful bidder shall be required to deliver desired valves, actuators, and control panels to Little Goose Dam in the time period shown in Section 8.0. The bidder must also provide documentation, and other items as stated in these specifications by this date.

3.0 BUTTERFLY VALVES 8” AND 12” IN DIAMETER

Butterfly valves shall be of wafer sort. These valves shall be tight closing rubber-seated type conforming to AWWA C504, Class 150B in its entirety. Valves shall be bubble tight at rated pressure. Valve bodies shall be constructed of ASTM A48, class 40 cast iron. The valve shafts shall be of stainless steel Type 304. Valve discs also shall be of stainless steel. The rubber seat shall cover the entire inner surface of the valve body extending over the outside face to form a flange gasket. The bearings shall be of a nonmetallic self-lubricating material. Metal-to-metal thrust bearings will not be allowed. Shop painting shall be in accordance with AWWA C504, except that interior surfaces of the valves shall be painted with Keysite 740, Engard 460, or approved equal in accordance with AWWA C550. Prior to painting interior shall be clean, dry and free of grease. Hydrostatic and seat leakage tests shall be conducted in strict accordance with AWWA Standard C504. Proof of Design Test reports illustrating that the valves meet the design requirements of AWWA C504 shall also be provided at time of submittal. Refurbished valves will not be allowed.

4.0 ACTUATORS

As an integral part of the complete valve assembly, there shall be provided a double acting cylinder actuator assembly designed, manufactured and factory assembled to the butterfly valve. The cylinder shall be rated for use with a 150-psi clean air power source. The actuators and accessories shall be pre-piped and contain the following features:

- a. Cylinder actuators for the valve sized 8” in diameter shall be of the scotch yoke type. The valves sized 12” shall be supplied with a compound link and lever arrangement. Each of these units shall comply with AWWA C540-93 Standard for Power Actuating Devices. All wetted parts of the previously mentioned cylinder shall be nonmetallic, except the cylinder rod, which shall be made of chromium-plated stainless steel. The rod seals shall be of the nonadjustable, wear compensating type. A rod wiper for removal of deposits inside the cylinder shall be provided in addition to an external dirt wiper.
- b. Speed control valves shall be installed to limit opening and closing speed. The opening and closing speed shall be adjustable from 30 to 150 seconds.
- c. Solenoid shall be provided for use in a throttling application. Solenoid shall be dual coil, three positioned, 120 V AC.
- d. Actuators shall include single pole, double throw limit switches and 1-100 Ohm potentiometer.
- e. Actuators shall also include a manual override to manually operate the valve in the event of power failure or loss of air supply.

5.0 SUBMITTALS**

Submittals shall include three (3) copies for approval of a shipment schedule, copies of system drawings, manufactures catalog cuts, O&M manuals, specification sheets and Proof of Design Test mentioned in section 3.0.

Contractor shall submit each item to the contracting agent. The Government will respond within 15 days of receiving each submittal item with ‘Approved’ or ‘Disapproved—Resubmit’. Contractor shall not place an order for, nor commence shipment of the water valves until all submittals have been approved.

6.0 INSTALLATION**

Factory representative and/or a contractor's service technician shall furnish instructions for recommended installation of valves and actuators.

7.0 OPERATION AND MAINTENANCE MANUALS**

Five complete copies of the Operation and Maintenance Manual will be required for each type of system. The manuals shall include instructions for the recommended installation, operation, maintenance, repair, and troubleshooting. They shall also include diagrams listing all system components, part numbers, and a list of recommended spare parts.

Also included shall be the name, phone and fax numbers, and email address of the contractor, manufacturer, and a distributor where spare parts and filters can be purchased.

8.0 SHIPMENT AND DELIVERY

All items shall be delivered FOB to Little Goose Dam within 3 weeks after the final submittal is approved, and 7 weeks after award of the contract. The contractor shall be responsible for packing and shipping the components in a manner that will ensure undamaged and complete arrival to Little Goose Dam. No shipments are allowed other than normal business hours of Monday-Thursday 6:30AM-5PM, excluding holidays.

52.212-3 OFFEROR REPRESENTATIONS AND CERTIFICATIONS--COMMERCIAL ITEMS (JAN 2004) ALTERNATE I (APR 2002)

Security Contract Language for all Corps of Engineers' Unclassified Contracts (PIL 2003-06, 19 Feb 03)

All Contractor employees (U.S. citizens and Non- U.S. citizens) working under this contract (*to include grants, cooperative agreements and task orders*) who require access to Automated Information Systems (AIS), (stand alone computers, network computers/systems, e-mail) shall, at a minimum, be designated into an ADP-III position (non-sensitive) in accordance with DoD 5220-22-R, Industrial Security Regulation. The investigative requirements for an ADP-III position are a favorable National Agency Check (NAC), SF-85P, Public Trust Position. The contractor shall have each applicable employee complete a SF-85P and submit to the Security Officer within three (3) working days after award of any contract or task order, and shall be submitted prior to the individual being permitted access to an AIS. Contractors that have a commercial or government entity (CAGE) Code and Facility Security Clearance through the Defense Security Service shall process the NACs and forward visit requests/results of NAC to the Security Officer. For those contractors that do not have a CAGE Code or Facility Security Clearance, the Security Office will process the investigation in coordination with the Contractor and contract employees.

In accordance with Engineering Regulation, ER 380-1-18, Section 4, foreign nationals who work on Corps of Engineers' contracts or task orders shall be approved by the HQUSACE Foreign Disclosure Officer or higher before beginning work on the contract/task order. This regulation includes subcontractor employees. (NOTE: exceptions to the above requirement include foreign nationals who perform janitorial and/or ground maintenance services.) The contractor shall submit to the Division/District Contract Office, the names of all foreign nationals proposed for performance under this contract/task order, along with documentation to verify that he/she was legally admitted into the United States and has authority to work and/or go to school in the US. Classified contracts require the issuance of a DD Form 254 (Department of Defense Contract Security Classification Specification).
