**SCOPE**

Contractor shall furnish and deliver a new drainage pump, Pumpex model PX 12 N (medium head) or equivalent, to Ice Harbor Dam. Government personnel will install and start-up the drainage pump and piping. The contractor shall also provide Operation and Maintenance Manuals. Two sets of technical documentation, including component specifications, drawings and pump curve data shall be submitted to the technical point of contact at site (through Contracting Office), for approval, prior to contract award. The new drainage pump shall be covered under a one-year warranty for material and workmanship.

**SYSTEM DESCRIPTION**

The drainage pump is required to reduce the load on already existing pump 7 located at the North Fish Ladder. The drainage pump will be used as a backup for the existing pump and will be placed and removed from duty numerous times over its life span. The drainage pump will be placed 45 to 50 feet below the deck and needs the appropriate piping to discharge from the point of placement plus approximately 10 feet to the edge of the deck.

**PUMP PERFORMANCE**

The static head and flow rate for the drainage pump is as shown in Table 1.

**POWER REQUIRMENTS AND ELECTRICAL CONNECTIONS**

The drainage pump shall be 480 VAC, 3 phase, rated for continuous duty. All electrical cables to station power shall be AWG 8/4 and left as pigtails and the required length for the electrical wire is shown in Table 2.

**PUMP LAYOUT**

The placement and removal of the drainage pumps will be done through a 25-inch diameter hole and shall be submersible. In order for this to occur the drainage pump must have a base diameter of less than 24 1/2-inches. The drainage pump shall have an integral float switch set at a water depth of 1-foot. The discharge piping for the drainage pump must be vertical. The size of the drainage pump discharge connection shall be a plain 8-inch NPT connection. All electrical connections to the drainage pump must also facilitate the 25-inch diameter hole and thus have vertical connections. The drainage pump must have lifting eyes placed on top of the pump.

## **PUMP LIMITATIONS**

The limitations for Horsepower and available Amperage for the drainage pump are shown in Table 3. These values are maximum values and shall not be exceeded.

## **SCHEDULE**

Delivery shall commence no later than 60 days after the receipt of contract award. The pump shall be delivered no later than 90 days after the receipt of the contract award. Contractor shall make prior arrangements with the Government Personnel at site to deliver and unload the equipment

Normal working hours at Ice Harbor Dam is 6:30 a.m. to 5:00 p.m., Monday through Thursday. The drainage pump shall arrive between 7:00 a.m. and 2:00 p.m. during normal working days. This is to allow for unloading and inspection. The delivery shall be made to the south side of the dam. The delivery address is as follows:

## **TRAINING AND MANUALS**

Contractor shall furnish three copies of O & M manuals, complete with recommended periodic maintenance schedules. The O & M manuals shall also include engineering data and a detailed parts list. The delivery of the manuals and training shall occur no later than 2 days after the final delivery.

## **WARRANTY**

Each unit shall be covered by a materials and workmanship warranty for a period of no less than one year from completion of installation. Installation by Government personnel shall commence no later than 90 days from delivery.

A component is considered to have been mined, produced, or manufactured in the United States (regardless of its source in fact) if the end product in which it is incorporated is manufactured in the United States and the component is of a class or kind for which the Government has determined that--

(A) Sufficient and reasonably available commercial quantities of a satisfactory quality are not mined, produced, or manufactured in the United States; or

(B) It is inconsistent with the public interest to apply the restrictions of the Buy American Act.

(3) End product means those articles, materials, and supplies to be acquired under this contract for public use.

(4) Foreign end product means an end product other than a domestic end product.

(5) Qualifying country means any country set forth in subsection 225.872-1 of the Defense Federal Acquisition Regulation Supplement.

(6) Qualifying country component means a component mined, produced, or manufactured in a qualifying country.

(7) Qualifying country end product means--

(i) An unmanufactured end product mined or produced in a qualifying country; or

(ii) An end product manufactured in a qualifying country if the cost of the following types of components exceeds 50 percent of the cost of all its components:

(A) Components mined, produced, or manufactured in a qualifying country.

(B) Components mined, produced, or manufactured in the United States.

(C) Components of foreign origin of a class or kind for which the Government has determined that sufficient and reasonably available commercial quantities of a satisfactory quality are not mined, produced, or manufactured in the United States.

(b) This clause implements the Buy American Act (41 U.S.C. Section 10a-d). Unless otherwise specified, this clause applies to all line items in the contract.

(c) The Contractor shall deliver only domestic end products unless, in its offer, it specified delivery of other end products in the Buy American Act--Balance of Payments Program Certificate provision of the solicitation. If the Contractor certified in its offer that it will deliver a qualifying country end product, the Contractor shall deliver a qualifying country end product or, at the Contractor's option, a domestic end product.

(d) The contract price does not include duty for end products or components for which the Contractor will claim duty-free entry.

(End of clause)

#### 252.225-7002 QUALIFYING COUNTRY SOURCES AS SUBCONTRACTORS (APR 2003)

(a) Definition. Qualifying country, as used in this clause, means any country set forth in subsection 225.872-1 of the Defense Federal Acquisition Regulation (FAR) Supplement.

(b) Subject to the restrictions in section 225.872 of the Defense FAR Supplement, the Contractor shall not preclude qualifying country sources or U.S. sources from competing for subcontracts under this contract.

(End of clause)
