TECHNICAL SPECIFICATIONS
PR&C 4180-7441
PORTABLE FALL PROTECTION SYSTEM

INTENT

The following specifications pertain to the purchase of a Portable Fall Protection system for use while performing maintenance on top of high voltage transformers.

SCOPE

The successful bidder shall be required to fabricate and deliver a complete Portable Fall Protection system to Lower Granite, Little Goose, and Dworshak Dams by the date shown in Section 7. He shall also provide training, documentation, and other items as stated in the specifications.

PORTABLE FALL PROTECTION SYSTEM

The system shall be a portable fall protection system designed specifically for use on top of high voltage transformers. It shall be designed to meet all applicable OSHA standards. The system shall consist of components as described below.

PORTABLE FALL-ARREST POST

Provide Portable Fall Arrest Post UCL part number 16691 with heavy duty carrying bag or approved equal.

Provide six post for Lower Granite Dam.

Provide three post for Little Goose Dam.

Provide three post for Dworshak Dam.

The Portable fall-arrest post shall be rated for a minimum of 3 workers at any one time. The post shall have a minimum of 3 telescopic working heights of approximately 30.5", 43 and 54.50" and have the ability to be used as an anchor for a temporary horizontal lifeline. The post shall have a minimum of three independent swivel tie-off rings that would allow a double locking snap hook and carabineer to secure to safely. The post shall offer a minimum safe working radius of 72" from the post. The post shall be capable of being stored in one carrying bag no longer than 33" and have a weight of no more than 38 lbs. The post shall be able to be installed on uneven surfaces to a maximum of 15 degrees from level. The post shall be designed to secure an optional 360 degree rotating davit arm without dis-engaging the workers. The post is to be manufactured out of lightweight 6061-T6 aluminum

WELD-ON PLATE

Provide Weld-On Plate UCL part number 17412 or approved equal.

Provide six plates for Lower Granite Dam.

Provide six plates for Little Goose Dam.

Provide four plates for Dworshak Dam.

The weld-on plate shall be designed to weld to the transformer and allow quick connection of the above fall-arrest post. The weld-on plate shall include a 5000 lbs tie-off anchor ring that can be secured to safely with either a carabineer or double locking snap hook.

SUBMITTALS

Prior to award of an "approved equal", submittals must be approved by the Contracting Officer or Specialist, POC Tony Van Loenen at 509-527-7212. Submittals include:

Copy of system drawings, manufactures catalog cuts, O&M manual, and warranty.

Provide 3rd party engineered certification sheet verifying design load moment requirements for field installation.

Provide certification sheet verifying system design meets all applicable OSHA standards for fall protection.

WARRANTY

Each system shall be covered by a minimum one-year warranty on all parts, labor, and workmanship from factory defects.

OPERATION AND MAINTENANCE MANUALS

Four complete copies of the Operation and Maintenance Manual will be provided for each dam (see Shipment and Delivery below). The manuals shall include instructions on the installation, operation, maintenance, repair, troubleshooting, warranty of the systems, and a list of recommended spare parts. They shall also include As-Built drawings showing all system components, part numbers, one line diagrams, and system outline. Any information pertaining to models or components not supplied under this contract shall be crossed out.

Also included shall be the name, phone and fax numbers, and email address of the contractor, manufacturer, and a distributor where spare parts and filters can be purchased.

52.212-3 OFFEROR REPRESENTATIONS AND CERTIFICATIONS--COMMERCIAL ITEMS (JAN 2004)

(f) The Contractor is responsible for the accuracy and completeness of the data within the CCR database, and for any liability resulting from the Government's reliance on inaccurate or incomplete data.
