In 1944, the Bureau of Reclamation constructed Payette Lake Dam, which in turn created Cascade Reservoir. The man-made impoundment is about eight square miles with a maximum capacity of 41,000 acre-feet of water. The primary purpose of Cascade Lake is to supply water to farm and pasturelands by way of a complex system of irrigation canals and laterals. The waterway meets the definition of a Category (4) "impoundment", as defined under 33 CFR 328 (a).

Interstate recreational enthusiasts use the man-made impoundment for boating, sport fishing, and water skiing pursuits. Cascade Lake also meets the definition of a Category (1) "interstate waterway", as defined under 33 CFR 328 (a).

Cascade Lake is a Category (5) tributary, as defined under 33 CFR 328 (a), because it flows into the North Fork Payette River, which flows into the Payette River, which flows into the Snake River, which is a Category (1) interstate waterway.
