Jurisdictional Determination (JD):

B. Waters defined under 33 CFR part 328.3(a) as "waters of the United States":

- (1) The presence of waters, which are currently used, or were used in the past, or may be susceptible to use in interstate or foreign commerce, including all waters which are subject to the ebb and flow of the tide.
- (2) The presence of interstate waters including interstate wetlands¹.
- (3) The presence of other waters such as intrastate lakes, rivers, streams (including intermittent streams), mudflats, sandflats, wetlands, sloughs, prairie potholes, wet meadows, playa lakes, or natural ponds, the use, degradation or destruction of which could affect interstate commerce including any such waters (check all that apply):

 - (ii) from which fish or shellfish are or could be taken and sold in interstate or foreign commerce.

Rationale for the Basis of Jurisdictional Determination (applies to any boxes checked above).

Farmer's Union Canal is a tributary to an interstate water (Category 5). It flows into the Middleton Canal, which flows into the Mill Slough, which flows into the Boise River, which flows into the Snake River, which is an interstate water (Category 2). Unnamed irrigation ditches (STAs. 54+00, 59+00, 69+52) are tributaries to an interstate water (Category 5). They flow into Dry Creek Canal which flows into Canyon Canal, which flows into 500 Lateral, which flows into the Boise River, which flows into the Snake River, which is an interstate water, (Category 2).
