C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The delineation surveyed a 42 acre parcel located along the north bank of the Boise River. The delineation identified 29.29 acres of forested wetlands and 1.19 acre of shrub-scrub, refer to exhibit 1. The delineation was conducted in accordance with the 1987 Corps of Engineers Wetland Delineation Manual and the Arid West Regional Supplement, Version 2, dated September 2008. A field inspection by the Corps was conducted on August 19, 2015 prior to the delineation being conducted. Areas that were suspected of being wetland and then determined to be wetland were either below the ordinary high water mark (OHWM) of the Boise River or were abutting the OHWM.**

The project area located on the north bank was reviewed and found that much of the 42 acre site is within the active flowing channel of the river at normal high water. Areas determined to be wetland are either inundated with flowing water or are abutting the high water mark. These photos are very similar to water conditions observed on the 2006 aerial photo's taken at normal high water. Site conditions have changed very little between 1982 and present day .

B. ADDITIONAL COMMENTS TO SUPPORT JD: The Corps has reviewed the wetland delineation of the 42 acre parcel on the north bank of the Boise River prepared by Ecological Design Inc.and agree with the finding in the delineation report. Approximately 29.29 acre of forested wetlands and 1.19 acre of scrub-shrub wetlands are present within the 42 acre parcel. These wetlands have been determined to be abutting and or contiguous with the Boise River and as such are subject to jurisdiction under Section 404 of the Clean Water Act in accordance with 33 CFR Part 328.3 (a) (7).
