Explain: **The review area entails a subsection of the property that was previously delineated on April 4, 2005. Wetlands delineated within the amended review area have reverted back to uplands, see Enclosure 2 (Dated September 29, 2016), sample points T1-OP1, T1 OP2, T1 OP4, T1OP5 data sheets. The report concluded that a change in irrigation practice has resulted in the conversion of wetlands back into upland within the re-delineated area of Lot 26, Block 1**

within Rivers End Subdivision Phase 3. Remnant hydric soils were still present and hydrology may be present during peak flows, however the dominant vegetation has reverted to upland species. All sample sites failed the dominance test for wetland vegetation, however T1 OP3 (Closest to the Boise River) did pass the prevalence index which was determined to be the most appropriate method. The final wetland/upland boundary was confirmed from the data sheets, and site visit with the consultant performed on 7/5/2016. Figure 2, dated September 29, 2016 illustrates the area of Lot 26 that was redelineated. This determination applies only to the area as indicated in Figure 2.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The April 2016 delineation as amended in September 2016 confirmed that the the local and site spcific transition from flood irrigation pasture land to residential development, has resulted in the reversion of wetlands to

uplands within the review area as shown in Figure 2. Wetland and open water features outside of the review area identified in the 2007 verification were not delineated and are presumed to still be determined a waters of the United States and are subject to regulation under section 404 of the Clean Water Act.
