C. PROJECT LOCATION AND BACKGROUND INFORMATION: The proposed project entails the following work: (1) excavate with a fixed blade bulldozer, a total estimate of 3,144 cubic yards of accumulated sediments from the established reservoir bottom elevation of 4813 or 5-foot average depth; (2) stockpile (temporarily) a total estimated total of 3,144 cubic yards of dredged material at the concrete boat ramp, below ordinary pool elevation of 4828 feet; and, (3) replace boat dock anchors up to 4 sets (8 anchors total), about 10 cubic yards of pre-cast concrete. In-water work activities will be performed during low pool level, Elevation 4816, to minimize sediment transport into Cascade Reservoir (North Payette River). The purpose of the project is to facilitate moorage of boats and navigation of watercraft into, and out of, the facility. Sediment removal would return the marina and access channel to "as-built" conditions.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Flows from the Cascade Dam discharge downstream into the North Fork Payeete River and merge with the South Fork Payette River, which form the mainstem Payette River. The Payette River flows directly into the Snake River below River Mile 445.5. .

B. ADDITIONAL COMMENTS TO SUPPORT JD: Cascade Reservoir is a man-made impoundment on the North fork Payette River. Water that is discharged from the reservoir flows into the North Fork Payette River. The North Fork Payette River merges with the South Fork Payette River, which forms the mainstem Payette River. The Payette River flows into the Snake River below River Mile 445.5. The Snake River is considered a traditional navigable water (TNW) under Section 10 of the Rivers and Harbors Act of 1899. Therefore, Cascade Reservoir (North Fork Payette River) is considered a tributary to the Snake River and thus is regulated under Section 404 of the Clean Water Act..
