Summarize rationale supporting determination: Black Canyon Reservoir is a navigable in fact impoundment on the Payette River a tributary to the Snake River a traditional navigable water established by Congress in 1932. Black Canyon Reservoir is an impoundment behind Black Canyon Dam a Bureau of Reclamation (BOR) facility. The BOR maintains two fee public camp grounds with boat ramps and docks. Triangle Park is located 1.8 mile downstream of the project area. Power boating and sailing boating occur on the reservoir. Power boating was observed adjacent the project site on the day of the on-site (9-4-2015) Based on the above, the project site is adjacent a navigable in fact (a)(4) water in accordance with 33 CFR 328.3.

2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is “adjacent”: On-site conducted on September 4, 2015. Entire site walked and wetlands are contiguous with Black Canyon Reservoir. Wetland community immediately adjacent the western end of impact area is 250 feet wide beginning at waters edge and extending landward. The wetland community immediately adjacent the eastern side of the impact area is 96 feet wide extending from waters edge and extending landward. The entire area is relatively flat. Wetlands within the eastern 2/3 of disturbed area were brushed off but not filled. Wetlands community is recovering with reed canary grass, false indigo and small fruited sedge being the dominate plants. This area is 80 percent covered with wetland plants and the remaining 20 percent being weeds and open ground. All wetland plants are facw or obligate. Soils were moist to the surface and there had been no rain for 2 to 4 weeks. Soil pit was chosen randomly and excavated to a depth of 20 inches. Gley soils (5PB 2.5/5- sandy gleyed soil-S4) began at 4-inches below the surface and extended to the bottom of the pit. Water table was at 15 inches with saturated soils to 11 inches. A single soil pit was excavated, as the area is uniformly flat. A second soil pit was excavated to a depth of 15 inches in the western portion of the disturbed area. This area was filled with 2 to 4 inches of earthen soil obtained immediately north of impact area from a higher upland area. Fill area is roughly 0.2 acre. Pit excavated through 2-inches of fill. Gley soils observed 4 inches below natural ground and extended to bottom of pit. Soil type the same as eastern portion Sandy Gleyed Soil S4. Area was mostly bare soil, some reed grass was coming through and with false indigo. The disturbed area still has an intact wetland community extending from waters edge to the disturbed area and varying from 150 feet wide to 38 feet wide.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Impact area is part of a larger 5.25 acre wetland complex adjacent Black Canyon Reservoir an impoundment on the Payette River. The impact area is a 0.46 acre notched area cleared from the larger wetland see attached aerial photo (Enclosure 1). The site is adjacent/contiguous with Black Canyon Reservoir an in fact navigable water. The site is a wetland as it was found to have greater than 50 percent wetland plants observed within the impact area or undisturbed area immediately adjacent. Soils

were determined to be hydric (Sandy Gleyed soil S4) and hydrology was present, water table at 15 inches below ground with soil saturation to 11 inches. Based on the above the disturbed area is a wetland that is subject to regulation under section 404 of the Clean Water Act..
