The subject site is locally known as Donkey Springs. It originates as a small 0.04 acre spring on Mr. Donald Pica's property and flows via a man-altered channel for approximately 900 linear feet into a concave landscape position identified as Wetland 1. The subject site wetland is currently an emergent, shallow water marsh connected by a straight ditch to another wetland (wetland 2) which is outside of the project area. Wetland 2 lies in a similar concave landscape position and includes a shallow open water pond. Wetland 2 is on lands reported to be owned in 2015 by Mr. Turner. A third offsite wetland (wetland 3) with another shallow open water pond drains to the wetland 2. The three wetlands/ponds all lie on a lava bench that is situated above the deeply entrenched Snake River. The locations are depicted on the enclosed Overview Map. The Overview images is from Google Earth Pro and the USGS Hagerman quadrangle are provided on enclosures. Wetlands and/or waters being considered in this evaluation include Donkey Springs, the connecting channel and Wetland 1.

A site inspection on 12 March 2015 with Mr. Pica and Mr. Turner which included all three wetland areas reveals there is no surface channel connection between these wetlands and the Snake River. The wetlands on the property owned by Mr. D. Pica are approximately 2300 feet east and south of the rim of the Snake River. A wetland arm from the wetland 2 lies approximately 710 feet from the rim of the Snake River. Wetland 3 lies intermediary between Wetlands 1 and 2.

A review of aerial images from Google Earth Pro for the years 1994 to 2014 indicates there may have been a ditch that connected Donkey Springs to another apparent spring channel that appears to provide surface flow connectivity to the Snake River. This could not be confirmed during the 12 March 2015 inspection. The inspection revealed this connecting ditch appears to be unmaintained with no indication it currently connects by surface flow to the Snake River. There is no current surface water connection between the Pica wetland and the Snake River.

The subject site wetlands do not appear on the 1992 or the 1949 1:24K USGS quadrangle map for the area. Other wetlands do appear to the west. At least three irrigation ditches (Sands, Bell, and Buckeye) appear to convey surface water from Billingsley Creek diversions north of the subject property. These ditches lie, east and upslope of the subject wetlands. Based on observations of other wetlands in the area it is probable that the subject wetlands are groundwater discharges resulting from irrigation canal bed loss in the region.

The National Wetland Inventory (NWI) Map depicts palustrine emergent wetlands at Wetland 1 and a mix of palustrine emergent and palustrine forested/shrub at Wetland 2. Wetland 3 has no notation. The USDA, Natural Resources Conservation Service Web Soil Survey (Soils Map) does not indicate the presence of hydric soils for any of the wetlands. The NWI and Soils mapping are enclosed.

A review of the Flood Insurance Rate Map, Panel 70250, effective date 6-19-1985 shows Donkey Springs, Wetlands 1 and the connecting channel are located outside of the Zone A floodplain of the Snake River.

An upland/wetland boundary was not established in the field as the subject Pica Donkey Springs wetlands appear to be isolated with no surface tributary connection to a downstream water of the U.S. The wetlands are not part of the Snake River floodplains as the Snake River is deeply entrenched at this location (greater than 30 vertical feet lower than the wetlands). The Pica Donkey Springs wetlands are not close enough to the Snake River to be influenced by the river and while proximate they are not adjacent the Snake River.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Based on the above evaluation Donkey Springs, Wetland 1 and the connecting channel are isolated with no surface water connection to another waters of the US. The spring source, Wetland 1 and the connecting channel do not cross state lines, do not support foreign commerce or recreation, are surrounded by uplands and are not located within a reasonable distance to the Snake River. In addition the wetlands are located outside of the Zone A floodplain. Given the above, the subject wetland spring, wetland and connecting channel are isolated and not subject to regulation under Section 404 of the Clean Water Act.
