NAME OF PROJECT OR INSTALLATION: Enter McNary, Ice Harbor, Lower Monumental, Little Goose, Granite, Dworshak, Lucky Peak or Mill Creek Project as appropriate and a short descriptive phrase for the project. Example: McNary Project, Boat Dock Stairway in ABC Subdivision, Lot 15, 1234 Main Street, Pasco, Washington

1. Name of institution or individual: This should be your name or, if you represent a commercial activity or government, the activity's or governments name. **EXAMPLES:** John Doe/ Boise Cascade/ Walla Walla County, Public Works Department. This entry is ***NOT*** to be the name of the archaeological contractor.

4. Type of Permit Requested: Selected from pull down a. (Surveys, limited testing/limited collections of lands identified in number 8.) or b. (To excavate, collect, and make extensive collections on specific sites described below in number 8.)

5a. Proposed Date Field Work Will Begin: This date should be at least 60 calendar days beyond Date of Application.

5b. Proposed Date of Performance Completion: This should be the proposed date that the preliminary report of work performed under the permit-being-applied-for is to be submitted to the Commander, Walla Walla District.

6. Nature and Extent of the Work Proposed: Describe work in sufficient detail so a person unfamiliar with the project can readily understand what is proposed and why. This information needs to be very specific, and should be provided by the professional archaeologist who will conduct the survey if permitted. **EXAMPLE:** Dig twenty shovel test probes a minimum of 35 cm in diameter to a minimum of 1 meter in depth at 5m intervals. Shovel test probes will be dug in two parallel transects, on 5m from the shoreline and another 10m from the shoreline. All soil will be screened through 1/8" hardware mesh, and all artifacts recovered will be recorded and returned to the hole from which they came.

7. Submit evidence of past projects undertaken by the archaeological contractor with emphasis on applicant's ability to initiate, conduct, and complete the proposed work. Include evidence of logistical support and laboratory facilities used in the past.

8a. EXAMPLE: NW¹/₄ Section 18, Township 9 North, Range 29 East, Willamette Meridian.

8b. Include sufficient information so a person unfamiliar with the area can easily locate the property for which the permit will be issued. **EXAMPLE:** McNary Project, Franklin County, Pasco, Washington, NW¹/₄ Section 18, Township 9 North, Range 29 East, Willamette Meridian, ABC Subdivision, Lot 15, Columbia River Shoreline.

8c. Provide a marked-up copy of a portion of the applicable U.S. Geological Survey (USGS) Quadrangle map if available, a local government subdivision map, or sketch that a person unfamiliar with the area could use to locate the property for which the permit will be issued. Include the applicable section, range and township information, north arrow, any pertinent land marks and property lines if available. Indicate specific area under investigation.
