Explain: . **The proposed project area is below a basalt cliff outcropping and surrounded by agriculture land. The southwest border of the project area runs along the Deer Flat Low Line Canal. However no discharge of fill has been proposed within the canal. The project site is 0.8 miles due west from the Snake River (RM 440). The project site elevation is 2338 ft while the above plateau elevation is 2610 ft. A review of the National Wetland inventory (reviewed September 11, 2015), Google earth aerial imagery (dated April 29, 2015), and USDA Web Soil survey found the proposed project to be on an upland site. The project area is upland and not subject to jurisdiction under section 404 of the Clean Water Act (33 CFR 325-332).**

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** : A review of the USDA soil maps for the project site reported that Cencove-Vanderhoff complex, Vanderhoff loam, and Bahem silt loam soils dominate the project site area. None of these soils are considered to be hydric. Each soil present within the proposed project area is a well drained soil. The water table depth at the project site for all 3 soil types was more than 80 inches deep, per the USDA soil map unit descriptions. The deeper water table prevents wetland vegetation from becoming established and hydric soils from forming. The frequency of flooding or ponding was "None" for each of the soil descriptions at the project site area, per the USDA soil map unit descriptions. No wetlands have been documented within the proposed project using the national wetland inventory mapper. The proposed project area is upland and is not within the Corps jurisdictional authority, pursuant to Section 404 of the Clean Water Act (33 CFR 325-332).
