- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The proposed project would reclaim the last section of a gravel and sand mine that has ceased operations. The site has been in operation in some capacity for over 20 years, and has consisted of excavating into the front slope of upland hills. -Review of available material found the following.**

-1981 NWI map dated 7/1981 shows the area to be uplands with no active mining on the east side of State Highway (SH) 55.

-1992 Google Earth Aerial shows the pit was active and existed on both sides of the SH 55.

-2002 Google Earth Aerial shows site being actively mined for gravel.

-2006 Google Earth Aerial shows site being actively mined for gravel.

-2009 Google Earth Aerial shows active mining on the East side of SH 55 has ceased, but active mining still occurring on west side of state highway.

-2014 Google Earth Aerial shows active mining still occurring on west side of SH 55, mining on east side has ceased, and several areas are becoming vegetated.

-2015 Google Earth Aerial shows west side of gravel pit is being reclaimed, to include site grading to allow for development possibly residential/commercial. East side of gravel operations being prepared for reclamation by Idaho Dept. of Lands.

-2016 Site visit performed in March of 2016 confirmed operations in the East pit had ceased and reclamation of site is planned.

Based on the above information, the gravel operation on the east side of the SH 55 has not been abandoned, and is now scheduled for reclamation. Per the preamble of the 1986 Corps of Engineers, Department of Army, 33 CFR Parts 320 through 330, Final Rule, Part 328.3, (e). Water filled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel, unless and until the construction or excavation operation is abandoned and the resulting body of water meets the definition of a waters of the United States, these features are not generally considered to be waters of the United States.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
