Explain: . **The proposed project area is south of Highway 200, near mile post 32.1. A site visit on October 30, 2015 confirmed the review of the national wetland inventory (NWI), Google Earth aerial imagery and USDA web soil survey finding that the proposed project is an upland site. No wetlands or stream channel were indicated to occur at the project site thus the project area is not subject to jurisdiction under section 404 of the Clean Water Act.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Marty Taylor, of Sewell and Associates LLC conducted wetland reconnaissance on Sept 14, 2010 and found no wetlands within the two test plots (10 meters in size). The soils (Mission Silt Loam & Odenson Silt Loam) are identified on the USDA National Hydric Soils list as “hydric”, however hydric soils indicators criterion was not meet due to the low chroma values that were observed during the field tests. Wetland test plot #1 found no hydrophytic vegetation, hydric soils and wetland hydrology present. Wetland test plot #2 had less than 5% cover of *Juncus balticus* (Baltic Rush) a hydrophytic rush however there was no indicator of hydric soils or wetland hydrology present. The threshold of 2 of the 3 indicators was not present at wetland test plot #2 to determine it to contain wetlands. Each wetland test plot was located at the low points of the project area. The proposed project area is upland and is not within the Corps jurisdictional authority, pursuant to Section 404 of the Clean Water Act.
